i. BANK BALANCES

The total bank balance was \$41,005 as at 30 April 2017 consisting of:

ii. DEBTORS

Total at 30 April 2017 was \$4,000 which is current.

iii. SPONSOR CENTRES

Sponsor Centres that are paying by instalment have been invoiced for the second instalment in early May.

iv. TOURNAMENTS

NTC

Final results for the tournament is a surplus of \$722 inc GST when the portion of the grant from Infinity Foundation (\$354) is included. Waiting on bank details to pay-out one prize.

Senior Nationals

Final results for this tournament is a surplus of \$332 inc GST when the portion of the grant from Infinity Foundation (\$1,144) is included.

Open Nationals

Total entry fees to date amount to \$13,510 of which \$7,425 is outstanding.

We have Board approval for expenditure on Bronze Coaches shirts and replacement shirts for the core TBNZ tournament committee members from TBNZ funds.

vi. FUNDING APPLICATION TO GRASSROOTS TRUST

After discussions, it was resolved that TBNZ should apply for funding to Grassroots Trust for the amount of \$10,966.00 to cover the cost for the lane fees for the qualifying tournament and airfares for the male and female tenpin bowlers (2) who will represent New Zealand at the 2017 Qubica AMF World Cup to be held in Hermosillo, Mexico from 4-12 November 2017.

6. TECHNICAL ADMINISTRATOR'S REPORT

Certification inspection and Certificate issued to the following centre:

At the present time, Super Strike Hasting's new lanes are being installed by Chris Usher from Australia. He will be doing certificate inspection and I will issue certificate upon his recommendations.

Friday 12th May 2017 - TBNZ lane reading equipment delivered to Tauranga with adequate tape to make sure that the proposed pattern is being put down correctly for Nationals.

Question was asked as to who pays for the tapes used for the Open Nationals at Tauranga? After discussions, it was agreed that since this is a TBNZ-run event, TBNZ will bear the cost for this.

7. TOURNAMENT MANAGER'S REPORT

NTC 2017 - even though team numbers were down from previous years, the event was a great success.

Senior Nationals 2017 - entries were up 16% from 2016. The introduction of a new event with a National Senior Cup, was a success as well.

NZ Open Nationals 2017 - entries are up 13% so far from 2016, with 428 entries received. Preparations are in progress and on target for managing the event (scheduling and scoring facility). Comparison shown below:

10. COACHING AND BOWLER PROGRESSION

11. MEDIA OFFICER REPORT

Need to find/develop an approach to promote our sport through the various media. Promoting the youth bowlers in our Facebook page proved to be very popular.

12. GENERAL BUSINESS

- Belle gave an update on the research that Kaleb Allardyce was doing for her on possible initiatives for the promotion of tenpin bowling targeting the juniors. The aim is to have a paper that can be presented to Funding Organisations and potential sponsors seeking support to promote tenpin bowling utilising the expertise of our coaches and Sponsor Centres
- Discussions were held (led by Shorty) regarding a forum/information sharing for the technicians in the bowling centres. Shorty will progress this further and will be looking to catch up again with a Kegel representative.
- After looking at the requirements, options are to be investigated for the following and to be included in the next catch up with Andrei Nicolas:
 - A facility for handling membership in a more efficient manner.
 - A Tournament Management Programme which includes financial reporting.
- The Job Descriptions were updated to reflect the current set up of the Management Team and will be sent to everyone accordingly.
- AGM preparations were also discussed. This is all progressing well.

 - o Josie is working with Ian with any updates needed to AGM notice on the website
 - A reminder that reports are required for the day from the following: CEO, Board, Tournament Manager, and Squad Manager
