8. SQUAD MANAGER'S REPORT

- Have compiled list of eligible members for the 2017 and invitations were sent out individually.
- Clarifications requested and dealt with regarding 2018 which will be a big year
- Target tournaments for 2017:

 - For the youth plan to encourage them to travel for the Sydney Youth Cup and Milo Tournament

9. GENERAL BUSINESS

- Belle and Pete looking at the feedback about the elimination round for the NTC
- Belle advised that he has informed Phil Wright about the why the tournament page does
 not currently show which is ranked or not the reason being we have not received full
 information from the centres. Also, explained to him that the SNTC is not ranked as this
 is a team event rather than an individual tournament.
- Bronze Course run last January all four (Mark Stretton, Rob Pollock, Don Adshead, Caz Adshead) who attended have passed.
- Ivena to fly to Christchurch on the weekend of the 18th/19th of February to run the Bronze Course for Keith Rankin, Claire Gow, Dan Ellis and Michael Burt
- Coaching and Coaches plans to be put in place for a National Coach Seminar prior to regional coaching commencing.
- Ivena (Education Officer) talked on her draft plan for 2017 which includes further
 education of recently qualified coaches broadening their skills about mentoring and
 focus. She would like to introduce guidelines for selected teams prior to their departure
 overseas to ensure they are 100% prepared and know what to expect.
- Lengthy discussion on the fate of the current TBNZ Facebook page, including the new Bowlers Forum being managed by David Davies. Need to get historical information from current Facebook group.
- Receiving payment by credit card ongoing discussion on this. Belle to explore further
 with Westpac. Agreed that for the Senior Nationals at Kapiti that we will request the
 centre to collect the payment for the masters and the amount will be deducted from the
 total lane hire for the duration of the tournament.
- Lengthy discussion on unsigned email letter received from a group purporting to be tenpin bowlers around NZ who want to set up a new Association/discussion group on Facebook. Agreed that Roger Tucker will initially do the draft response and for Belle to present this to the Board so we only have one collective response from the whole body.
