Changed from "The selection panel shall have three members and the recognised Head Coach for that division." to "The selection panel shall have three members and a recognised Coach for that division."

Reason: We do not have a Head Coach for each division.

Selector Guidelines, paragraph 4

Added " Must have bowled at least one ranked event outside of their recognised home centre."

Reason: It is important to know that a bowler potentially representing overseas can perform outside their comfort zone.

Junior, Youth, Senior and Grand Senior changed to TBNZ18, 21,50 and 65.

TBNZ65 Team,

Changed from " ...the automatic selections are the highest ranked Grand Senior and and woman athlete.." to "..the automatic selections are the highest ranked TBNZ65 man and woman athlete on the TBNZ50 Ranking list for the closest quarter ended prior to selection..."

Reason: We do not have a TBNZ65 Ranking list so need to use the TBNZ50 one.

5. Lane Pattern Criteria

Change maximum side to side ratios for Grade 2 tournaments from a maximum of 8:1 to "a maximum side to side ratio of 6.5:1"

Reason: The Lane Patterns Sub Committee recommended this change as centres were putting down too many patterns above 6.5:1.

Grade 3 tournaments will have no limit.

Lane patterns now only require to be posted two weeks before the tournament. That was a recommendation from the Lane Patterns Committee so that the home centre doesn't get that much notice and laying the pattern down for their home bowlers. Traveling bowlers will still have time to assess and make gear choices.

6. e)

Changed from "Where TBNZ18 and TBNZ21 athletes are combined into one division, ranking points will be allocated relative to other males and females within their age group. I.e. ranking points will be allocated for TBNZ18 Girls, TBNZ18 Boys, TBNZ21 Women and TBNZ21 Men with points to be awarded as per clause 7." to

"For TBNZ18 and TBNZ21 where the host centre's tournament rules state there are separate TBNZ18 and TBNZ21 divisions, ranking points will be allocated based on each division. If the tournament rules confirm there is only a TBNZ21 division then only TBNZ21 ranking points will be allocated. If the tournament rules state that there are TBNZ18 and TBNZ21 separate divisions but because of numbers the centre elects to combine divisions then both TBNZ18 and TBNZ21 ranking points will be allocated based on the finishing position within each age group. In this case the bowler will need to nominate which ranking division they will be competing in. If no nomination is confirmed prior to bowling then the bowler will receive rankings points appropriate to their age."

Reason: The change clarifies what happens when a centre changes the divisions available.

6g)

Add the sentence "If any bowler was unable to compete due to disqualification then no ranking points will be allocated."

Reason: self explanatory.

6. Ranking Method/Graded Rankings

Delete this paragraph and no longer compile a Ranking List for Graded bowlers.

Reason: The ranking list was meaningless as it included ranking points from Graded TBNZ18 events where TBNZ21, Open and TBNZ50 and 65 could not compete. Also included Graded TBNZ50 and 65 events which others couldn't enter.

General Rules e)

Delete the first sentence "Centre based only tournaments cannot be ranked."

Reason: The paragraph did not make sense as it was written.

Note: Changing the number of tournaments that earn ranking points for Open and TBNZ50 bowlers from best 5 to best 6 was not approved due to the lack of tournaments in the Wellington region in 2024.
