Another bowler is interested in coaching and another just needs to complete the practical component to be certified.

3.5 Sport Integrity Commission

New Zealand representatives are required to have completed Clean Sport 101 training before traveling overseas, with upcoming trips to Hong Kong, Reno, and the TBA 50 in Australia.

This course only has to be done for a bowlers first overseas tournament and does not need to be retaken for every trip.

3.6 Tournament

A successful TBNZ50 National Teams Championships was completed last weekend with 11 teams participating.

10 teams will compete at the TBNZ21 National Teams Championships at the end of September. So far 73 All Event entries have been received for the TBNZ18_21 Nationals.

Centres are been requested to submit which TBNZ tournaments they use to host for 2026 and three have responded so far.

Pete proposes revamping the NTC tournament format by moving away from the current 5-person teams with Baker format, to a format similar to the old inter regional format with singles, doubles, and teams of 4 players. The new format would have separate men's and women's divisions with 8 players total per team. It would use a points system based on overall placings rather than head-to-head matches. It will allow senior bowlers to participate more easily since they would bowl in blocks of 6 games rather than 6 hours a day for 3 days. This change would benefit centers by freeing up lanes for public use during the tournament and would allow bowlers to achieve 1,000 game plaques in 6 years instead of 9-10 years.



Change the NTC format

Pete proposes changing the NTC tournament format to match the seniors format, with teams of 4 men and 4 women, while keeping the youth format as is due to difficulties in finding enough female youth bowlers. The entry fee would be around \$1,600 per team, similar to seniors, this amounts to about \$200 per bowler which is standard for tournaments. Melonie supports keeping the junior youth tournament format unchanged while adopting the seniors format for adult tournaments, as this protects younger bowlers from mismatches.
