Acknowledged the challenges faced by Wellington's bowling community, including the exodus of experienced bowlers and the lack of tournaments in the region.

The issue of the Wellington Open Tournament was discussed, with concerns raised about the lack of participation and the need for a solution to attract more bowlers.

However, no concrete solutions were proposed.

New Ball Registration System Discussion

A new ball registration system for the NTC has been created by Melonie.

It allows for electronic registration and data collection.

The registration deadline is set for the start of the tournament, with a penalty of a 0 score for a session if a bowler is caught with an unregistered ball.

Adding a feature to email the registered balls to the players for reference was suggested and this should be implemented.
