4. Policy Review

4.1 National Squad & Team Selection Policy Review



Amend Policy Wording

"Consideration of a bowler willing to travel to at least one ranked event outside their recognised geographic region. These regions are defined as Taupo North (Auckland, Bay of Plenty) and Taupo South (Hawkes Bay, Palmerston North, Wellington). For overseas-based athletes, this includes travel to tournaments outside their home city or back to New Zealand."

To be sent back to the Management team to make this more Black and White and not subjective.

Under the Automatic Selection Positions section (page 2, point 2)...

Under the Automatic Selection Positions section (page 2, point 2), it is suggested that the phrase “twelve months after it is earned” be replaced with “once the team has been announced.” In addition it is proposed that point 4 be relocated to the squad policy as it relates to squad selection not team selection.

4.2 Ranking Policy



Change wording in Ranking Policy

“Tournaments which are scheduled later in the current year than the previous year will remain in the rankings until the current year's tournament date.”

In addition it is proposed that the existing section g)ii be renumbered to g)iii and its wording revised to:

“Tournaments not scheduled in the current calendar year will remain in the rankings until the anniversary of the previous year's tournament completion date.”

Under the new format: The points table will display each bowler's ...

Under the new format:

- The **points table** will display each bowler's name, centre, total points, and the number of tournaments entered per division.
- The **statistics report** will consolidate all bowler statistics currently shown and will be published separately for male and female bowlers in alphabetical order.
- The existing **data sheet**, which details each bowler's points per tournament and highlights those contributing to rankings, will remain unchanged.

This restructuring will streamline the administration of the ranking system and improve the presentation of published data.

To implement this change, the following amendments to the General Rules are proposed:

- Revise section h) to read:

"Bowler statistics to show all games from all grades and tournaments in alphabetical order."

- Delete sections i) and j), as they are no longer required under the new reporting format.

Examples of the updated points table and statistics report are attached for reference. A revised page of the ranking policy, incorporating the proposed amendments, is also included.

4.3 Urethane / Ball Usage

A long discussion was had about options for limiting the impact of Urethane balls.

The modern use of urethane can and does change the lanes and pattern significantly, effectively changing the playing environment to one in which areas where urethane has been in use are significantly harder to achieve consistent carry.

The problem with the resultant carry down is that there is no adjustment that will work to get around the problem of carry down and drier heads outside of using urethane and having a high rev rate.

Options discussed included : -

Separating the Men and Women on the lanes.

Separate Lane conditions for singles/doubles and teams in Nationals.

Changing Ball surfacing rules.

Removing Urethane use entirely.

Limiting number of Urethane balls allowed.



Limit use of Urethane balls

In TBNZ tournaments with Ball registration, Only one of the six registered balls can be Urethane.

Change the definition of the "session" back to a block and not at lane changes in the TBNZ playing rules
