4.1 Ranking Policy Review



Update Ranking Policy

Currently the policy states “*Other tournaments scheduled in the current calendar year can remain in the rankings until the anniversary of the previous year’s tournament completion date*”

In 2025 this caused the Open Nationals ranking points to be removed which has a major impact on the rankings and the board made an exception and requested that the policy be amended to avoid this problem in the future.

The suggested changes are to insert a new section g)ii which reads

“*Tournaments which are scheduled later in the current year than the previous year will remain in the rankings until the current year’s date*” and amend the now section g)iii to read “*Tournaments NOT scheduled*”

4.2 National Squad and National Team Selection Policy review



Change wording

“Consideration of a bowler willing to travel to a minimum of one ranked event outside of their recognised geographic region. The regions are defined as Taupo North (Auckland, Bay of Plenty) and Taupo South (Hawkes Bay, Palmerston North, Wellington). For overseas based athletes this would include travelling to tournaments outside of their home city or back to New Zealand.”

Add non-refundable Deposit

“A \$250 non-refundable deposit is required within 7 days of the team being named. Funds are to be used against team expenses. If a bowler withdraws from the team only the Board can approve the refund of the deposit, the request must be made in writing stating the reason for the withdrawal.”

Change Policy Wording

Automatic Selection Positions on page 2 of the selection policy in point 2 the wording *“twelve months after it is earned”* be replaced with *“once the team has been announced”*

“Declining an invitation to the National Squad does not preclude an athlete who qualifies at a later date by way of Ranking, Nationals or National Teams’ Championships from accepting a new invitation, regardless of the time between the invitations being offered. It is accepted that a person’s circumstances that led to declining the invitation may have changed” should be in the squad policy.
